This full time position (36 hours) will join our group practice which includes a family practice physician, a pediatrician, two family nurse practitioners and a physician assistant.

Physician will care for a wide range of patients including children, adults and the elderly. Most of our patients are uninsured with a significant minority on Medicaid and Medicare. A small percentage of our patients have private insurance.
