# FQHC, What is it?



- Be located in an underserved area
- Provide services to **all** in their service area (focusing on persons under 200% FPL)
- Offer a sliding fee schedule that adjusts charges according to household income
- Provide comprehensive primary health care services (behavioral health, medical and dental)

# FQHC, What is it?

- Have expanded hours of operation
- Be governed by a community-based board of directors (51% of whom must be patients of the center)
- Report to our funders annually progress toward meeting key quality measures

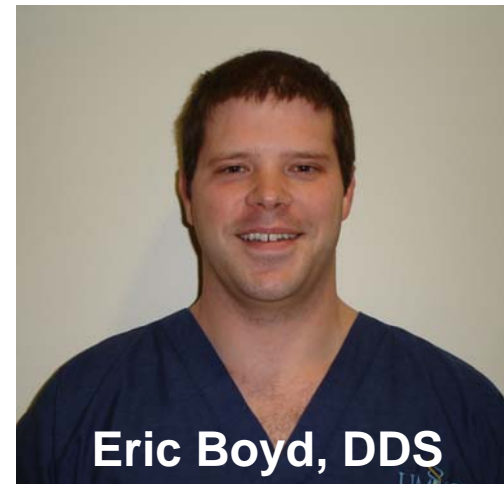

4% are African American

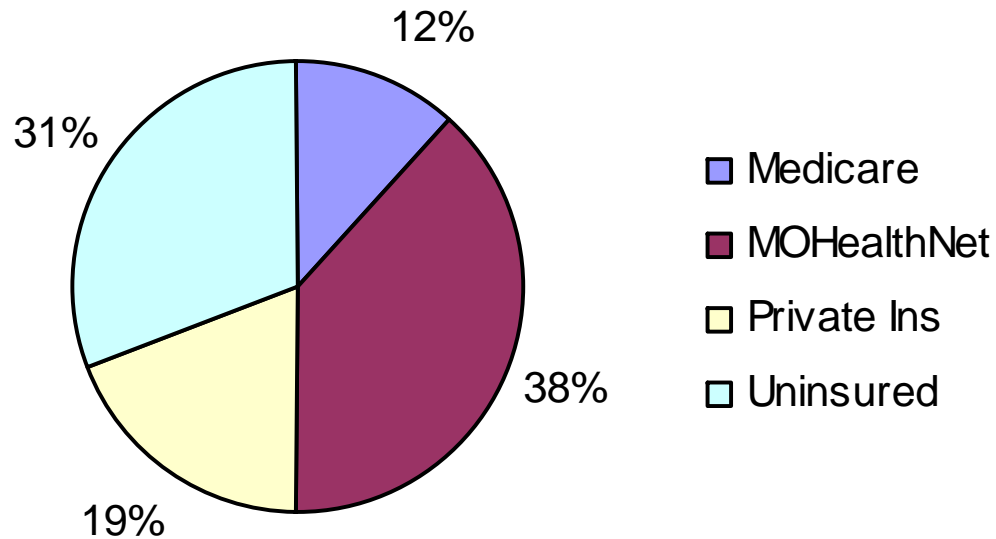
27% are children 19 years or younger

**PATIENTS BY PAYER SOURCE**



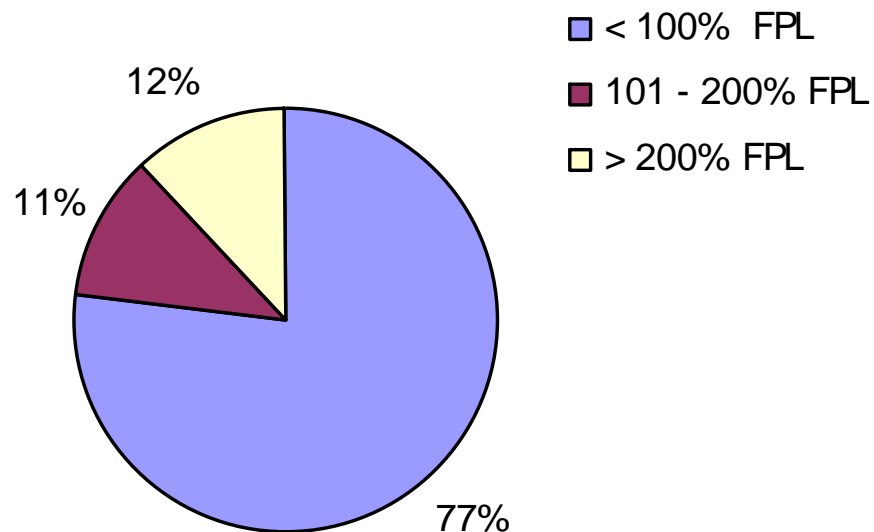
31% of KTCH patients have no health insurance

# Who Are KTCH Patients?



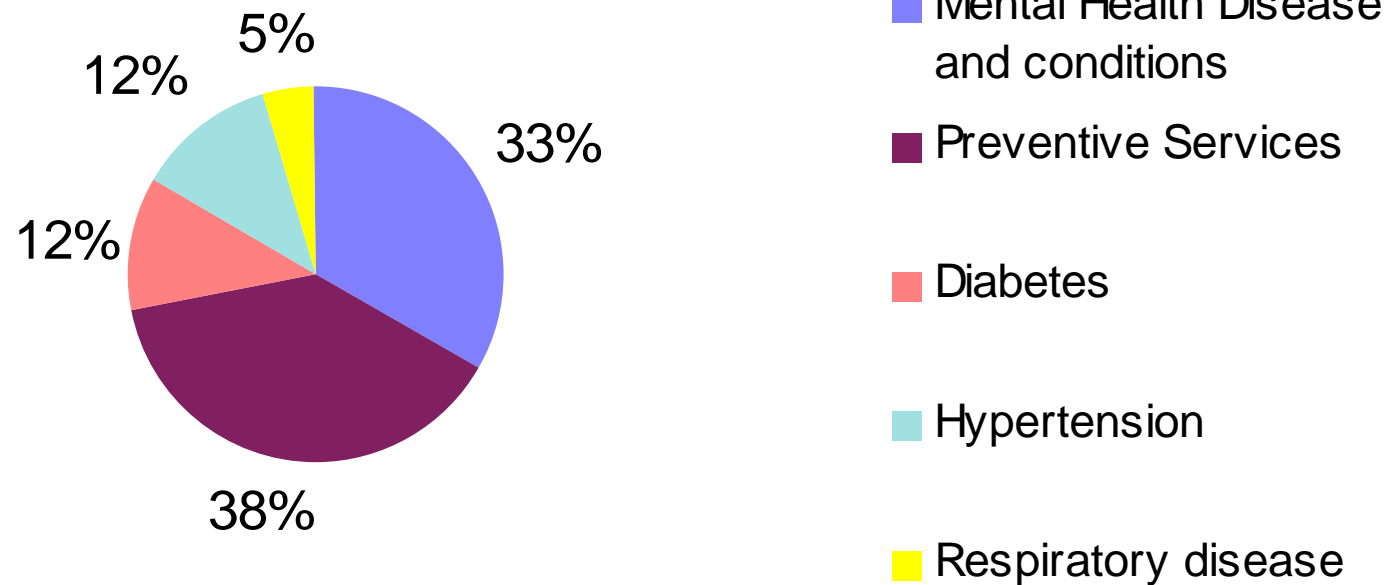
Patients by Income Level

## Top 5 Diagnosis

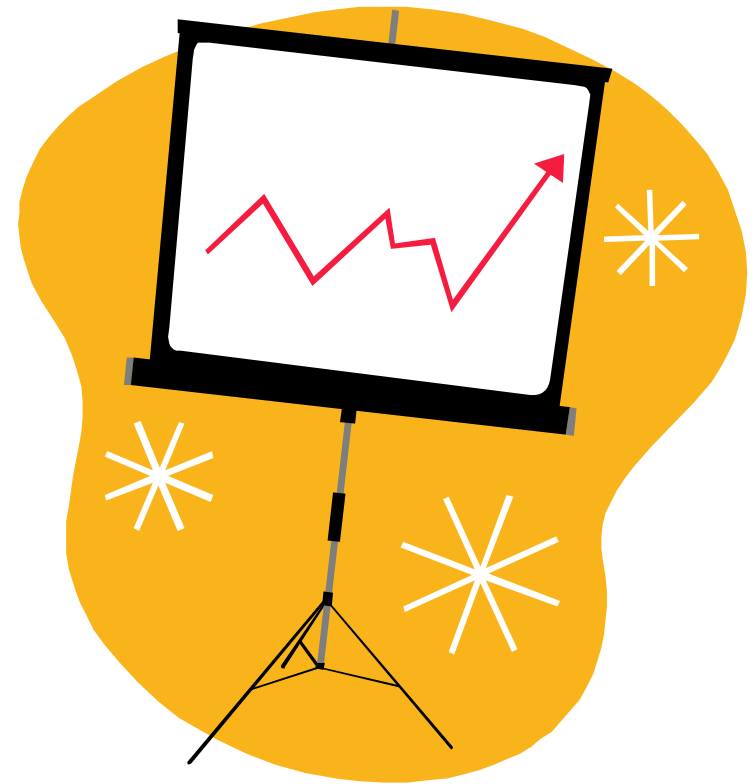

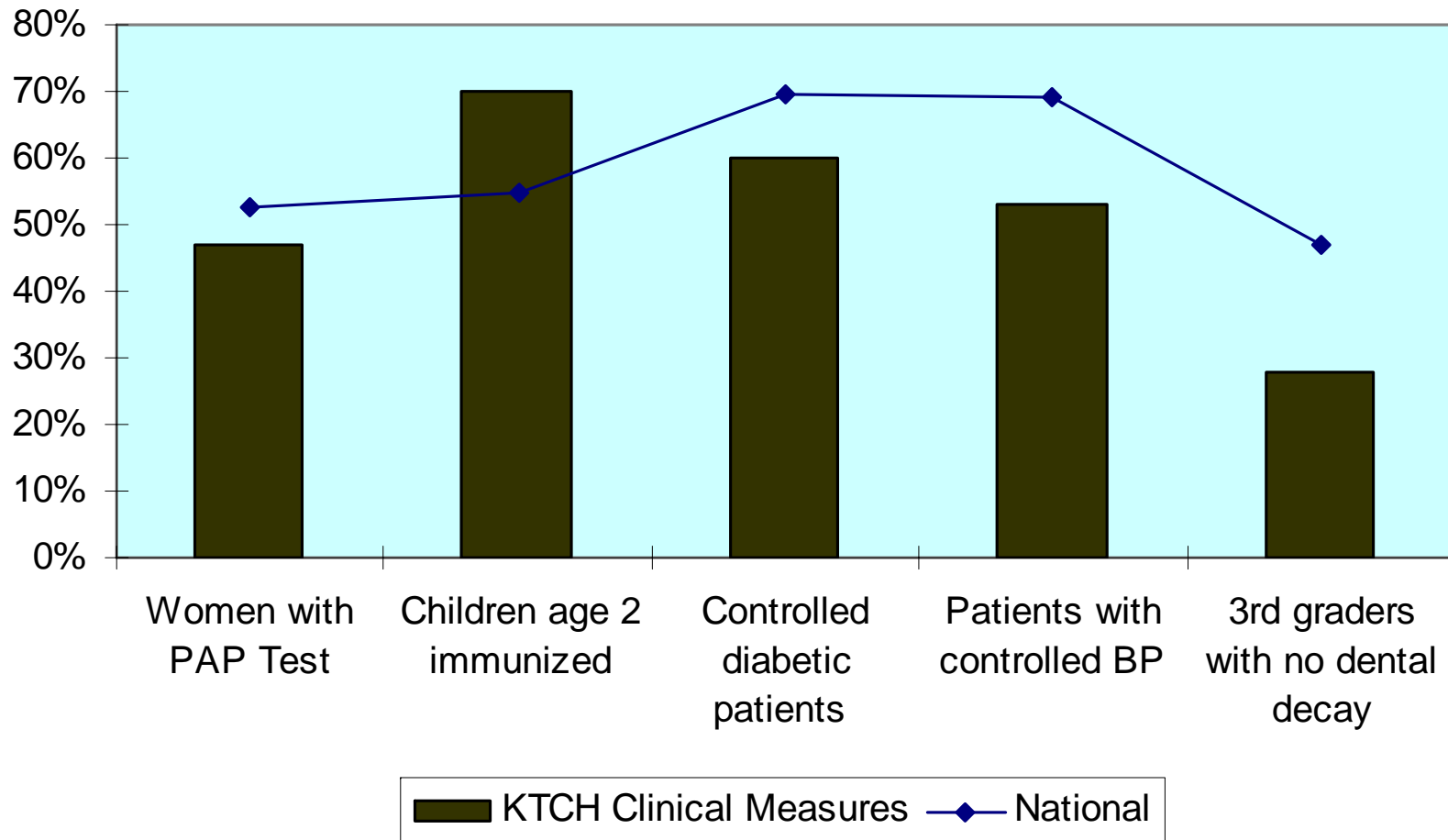

# What's new in 2009?

- Show Me Healthy Women
  - We provided free screening to 193 women
- Case Management Services
  - Presumptive eligibility for MOHealthNet
    - 450 people were enrolled in MO HealthNet
  - On site interpretation and translation
    - We now have 5 English/Spanish bilingual employees and 5 English/Russian bilingual employees

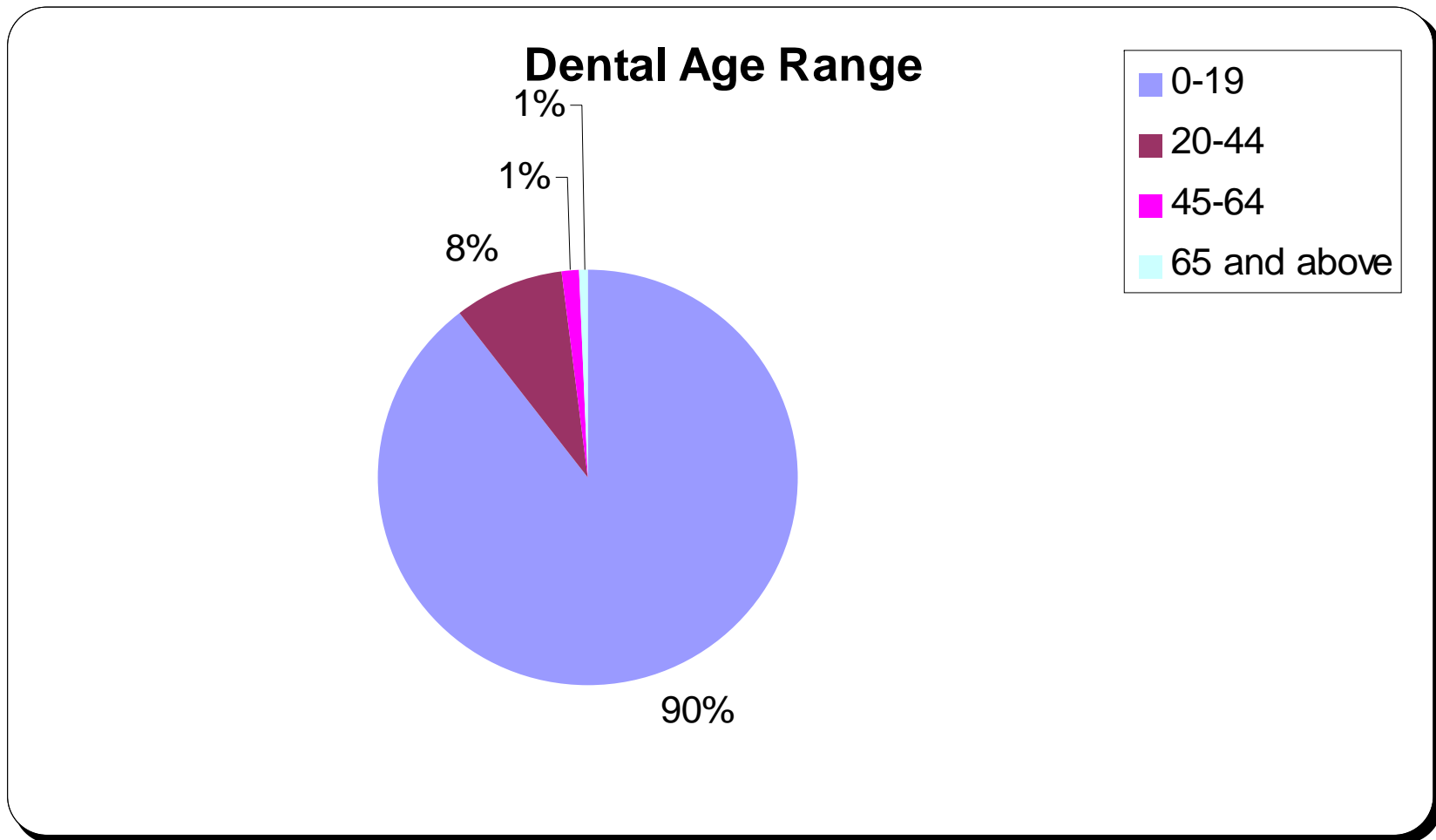


## Purpose of Dental Program

Prevent disease from starting in the youngest members of the population and decrease the existing dental disease burden.

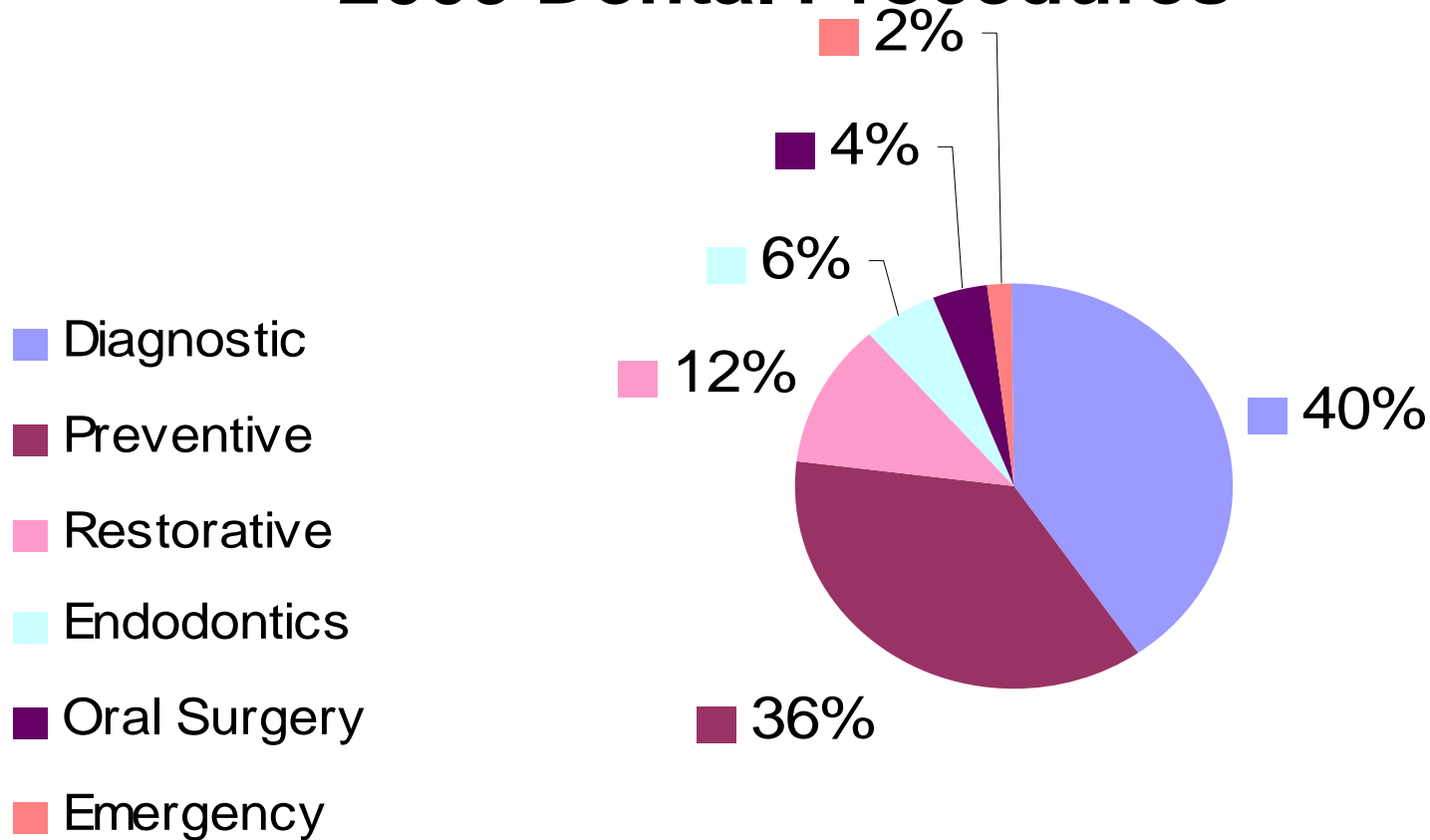

  - Care Connection for Aging Services

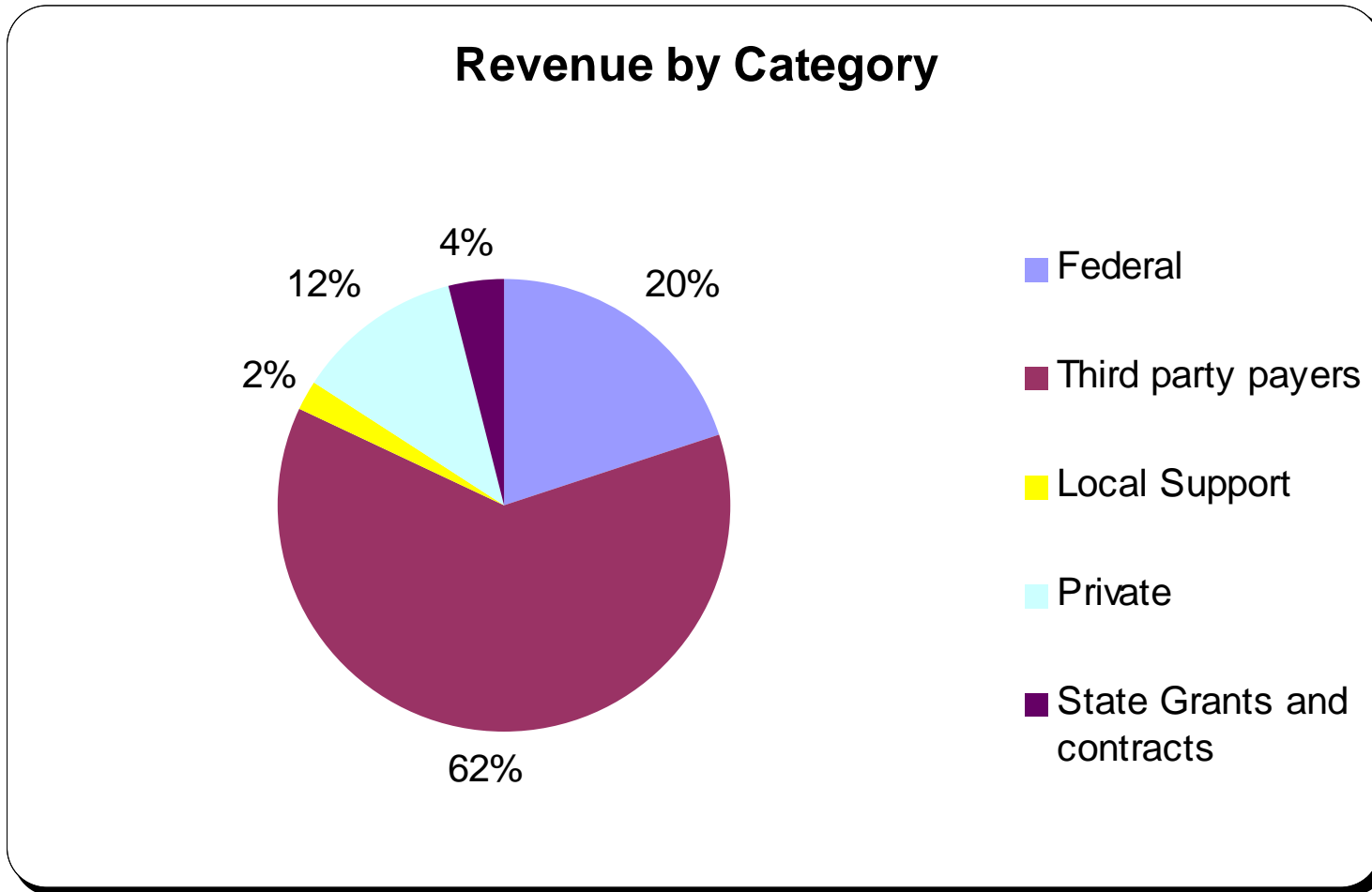

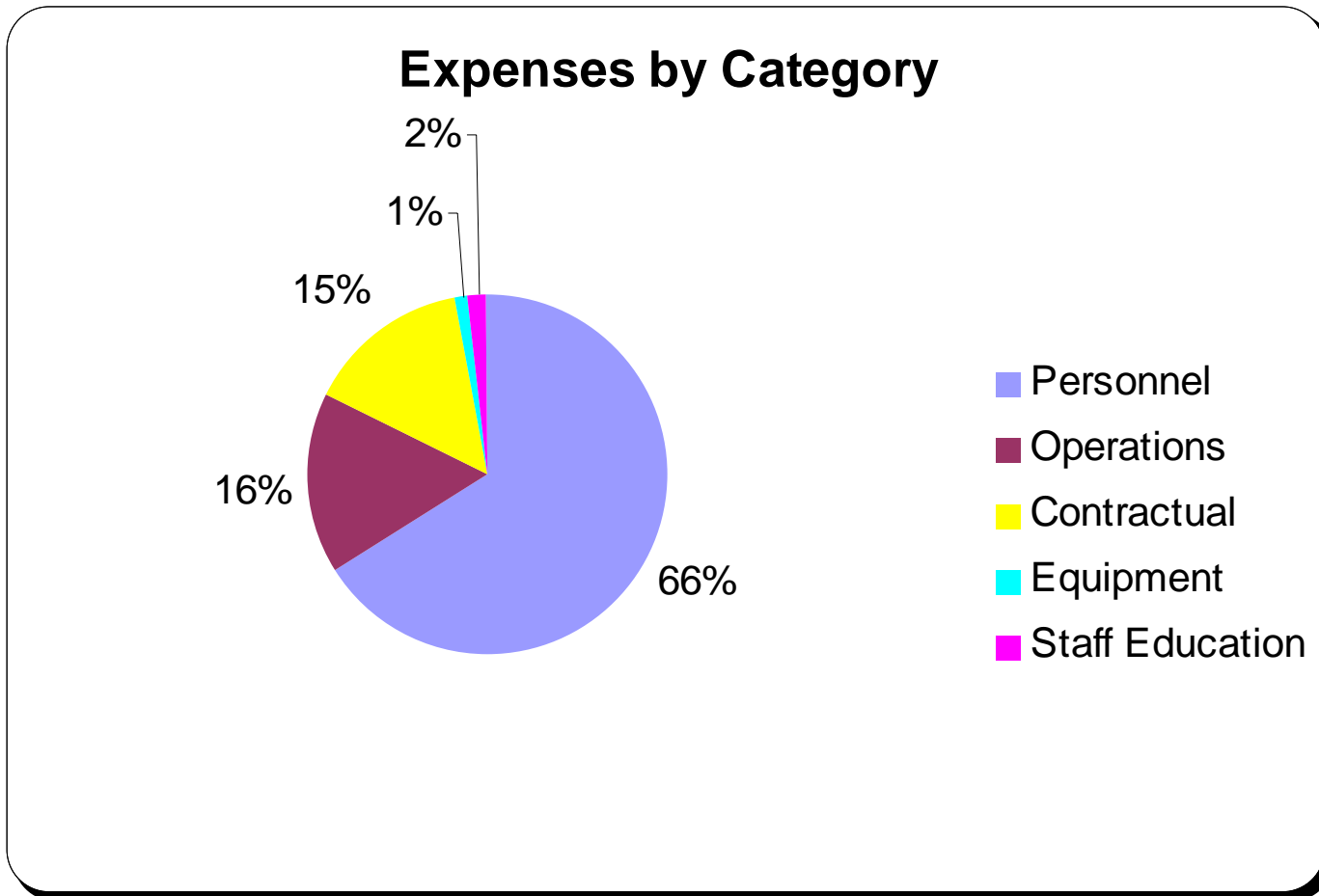


## What we brought In: \$3,265,865
